Huawei Technologies Co. Ltd. vs. ADIT [2020] 122 Taxmann 130 (Delhi - Trib.)

Income from the supply of telecommunication network equipment, installation, and commissioning of the same is taxable in India

Assessee, a Chinese Company was engaged in the business of supplying and installation of telecommunications network equipment's to telecom companies in India through its Indian subsidiary. Mumbai Tribunal grants tax credit for taxes withheld in Japan on professional income under India- Japan tax treaty;

Companies (Incorporation) Amendment Rules, 2021

The Ministry of Corporate Affairs vide notification dated 25 January, 2021 has issued the Companies (Incorporation) Amendment Rules, 2021. The amendment provides that the regional directors shall while considering the application for conversion of a company, if he is satisfied that the conversion would not be against the interests of the company or is not being made with a view to contravene or to avoid complying with the provisions of the Act, shall allow it. **Read More...**

Companies (Corporate Social Responsibility Policy) Amendment Rules, 2021

The new concept of Form CSR-1 (registration of entity with Central Government), has been introduced vide notification dated 22-01-2021.
